# Guidelines for grants from £1,001 to £20,000



Sleaford Renewable Energy Plant, owned by Glennmont Partners, in partnership with North Kesteven District Council, Sleaford Town Council and Kirkby La Thorpe Parish Council has made funding available via a Community Benefit Fund to support community projects within Sleaford Town and Kirkby La Thorpe Parish. Applications will be considered on a quarterly basis by the Sleaford REP Community Liaison Panel, which was established on 15 January 2013 under the community wellbeing powers contained in the Local Government Act.

## **Funding Available**

- We have an allocation of £120,000 to distribute over a 3 year period. We aim to distribute £40,000 per year. This will be split equally with an annual allocation of £20,000 towards projects in Sleaford Town and £20,000 towards projects in Kirkby La Thorpe Parish.
- Grants are available up to a maximum of £20,000 in any one year.

### **Objectives**

For a project to be supported by the Community Fund it must meet the following objectives:

- Improve the lives and wellbeing of people living within the boundaries of Sleaford Town and Kirkby La Thorpe Parish.
- Benefit the community.

## **Eligibility**

To be eligible to apply groups must have:

- · A constitution, or governing document, and
- A bank account or building society account.

Groups must be not for profit and be based and operate within the boundaries of Sleaford Town and Kirkby La Thorpe Parish.

## What can we Fund?

- Allotments and green spaces.
- Art and drama groups.
- Capital projects.
- Children and toddler groups.
- Community groups.
- Disability support groups.
- Local markets.
- · Lunch clubs.
- Putting on an event, activity or performance.
- Purchase of new equipment or materials.
- Schools (provided project is not a core curriculum activity).
- Sports and youth clubs.
- Volunteer training and activities that meet an identified need, including start up costs (e.g. venue hire, stationery etc.).

#### What can't we Fund?

- · Applications from individuals.
- Contributions to large appeals.
- Profit making organisations.
- Political or faith based groups, unless the activity is accessible to all the community.
- Projects or organisations outside of Sleaford Town and Kirkby La Thorpe Parish.
- Projects which are routine maintenance.
- Statutory responsibilities (e.g. projects which should be funded by a statutory body).
- Retrospective funding We will not fund projects which have already been started or commissioned.
- Utility bills.

#### **Grant information**

- Applications will be considered during quarterly Sleaford REP Community Liaison
  Panel meetings. These are scheduled to take place on 4 October 2016, 24 January 2017 and 21 March 2017.
- Payments to be made on receipt of invoices, unless agreed otherwise.
- All funds to be spent within 12 months from the date of the offer, unless agreed otherwise.
- The Sleaford REP Community Liaison Panel will not consider any additional application from a group that has already received funding during the same 12 month period.
- Groups may re-apply for additional funding after 12 months. Applicants requesting grants for consecutive years must prove that the project has developed.
- For capital projects applicants should have a freehold or leasehold of the property/land they intend to develop. If leased we would expect at least 15 years remaining.

## **Deadlines and notification periods**

- The deadline for applications is midnight on 12 September 2016, 2 January 2017 and 27 February 2017.
- The Panel will in exceptional circumstances

accept late submissions. These will be at the discretion of the Chairman.

 Applicants will be informed whether their application has been successful within 5 working days of the Sleaford REP Community Liaison Panel meeting.

## **Required supporting documentation**

- Constitution or governing document for your organisation.
- Your organisation's last set of audited accounts or income and expenditure details and a copy of a bank or building society statement. We expect accounts to be held in your organisations name.
- If applicable 3 quotes e.g. for building work and purchases.
